Basic and prescribed loads, except Class III will be carried. Basic load small arms (ammunition) for individual weapons and 1 days ration, individual, combat, will accompany troops. The 1 day ration to accompany troops is to be obtained from the 5 days ration authorized for deployment. Units will be prepared to live in the field using minimum essential accompanying equipment (MEE). Equipment shipped dir by sources of sup will be marked with proj code as indicated above and supplementary address code at 8887.

Personal clothing (enl personnel, AR 700-8400-1; off and WO required to purchase items TA 50-901 zone 1) and organizations clothing and equipment as prescribed in para 21, AR 220-10 (POM); para 28, AR 735-35 and zone 1 of TA 50-901; plus organizational clothing and equipment as specified in DA msg 721221 DTG 241827Z Jun 65 will be carried. Gas mask with corrective lenses will be issued prior to departure of personnel who require them. Bag, sleeping; case, sleeping bag; mattress, pneumatic will be additional accompanying MEE items.

Unit commander will report all departures of personnel and/or equipment to this headquarters, ATTN: G3, phone BELmont 9-3822 during duty hours and BELmont 9-3337 during non duty hours giving the number of officers and enlisted men, time of departure from Fort Riley, Kansas. Report will include strength and mode of travel.

Emergency medical support from civilian facilities is authorized when military medical assistance is not reasonably accessible. Troop commander will, without delay, notify this headquarters, ATTN: G3, G1 and Post Surgeon, of any civilian treatment rendered, to include names of individuals treated and names of attending physicians and their address, provisions of para 7c(2), AR 614-60 and Ft Riley Memo 40-3 apply when personnel are hospitalized in a civilian medical treatment facility.

In the event of death, troop commander will notify this headquarters, ATTN: G1 and AG so the provisions of Ft Riley Regulation 600-67 can be complied with.

The unit commander will notify the G4, this headquarters, when the installation property book has been reduced to a "Zero Balance" and the property book and allied documents are ready for inspection. This action will be accomplished not later than one working day prior to WP date.
